Arbitration proceedings shall be held in Bangalore, India, and the language of the arbitration shall be English. I agree that the decision of the arbitration shall be final and binding and shall be enforceable by any court of competent jurisdiction, and the Parties hereby irrevocably waive any objection to or claims of immunity in respect of such enforcement.
