This Circular is being sent due to many complaints having been received by us from different parts of the States of India and from many of our Independent Distributors mainly the lesser privileged Distributors of 1A to 3 A. complaining that the upline Distributors of 5A, 6A, and 6A 2- distributors who are privileged are offering discounts ranging from Rs 10,000/- to Rs 50,000/- to Rs 100,000/- and more depriving these distributors and the new prospectus to conclude a sale. It is a sad state of affairs and regretting to note the reality of the situation.

It is our humble request keeping in mind the long term relationship we are continuing to have with our Esteemed Independent Distributors that this practice must stop with immediate effect
